History

Established on February 10, 1988 by a group of local citizens to provide an avenue for charitable giving in our area.

Donated funds are dedicated to worthwhile endeavors in the greater Viroqua area.

VAF is a 501(c)(3) tax-exempt charity and gifts are tax deductible to the fullest extent of the law. You receive tax benefits in the year your gift is made. The funds are invested for long-term growth. The principal is preserved while a portion of the value of the endowment is available for area charitable projects and programs.

Charitable interests can be created within the VAF to benefit community projects, the arts, schools, students, parks, scholarships, families and service projects.

We can set up a fund in your name, in the name of your family or business, or in honor of a person or organization you choose. Endowment Pass Through accounts may be established.

We assist you in setting up your named fund by discussing if your fund will be an Unrestricted Fund: these are funds which have no restrictions as to how the gift is used; or a Restricted Fund: these are funds which are established to benefit specific charitable organizations which are named by the donor.
